## Who should complete this form

A potential donor who is:

- an individual not enrolled within the meaning of the Electoral Act 2017; or
- an individual not enrolled for federal or local government elections; or
- an entity without a relevant business number.

#### When to lodge

This form may be lodged with the NSW Electoral Commission at any time, but must be lodged and approved before a political donation is made.
