

## **Appointment of Scrutineer** (Amended) ◆

Section 337 of the Local Government (General) Regulation 2021

I as a candidate appoint the following scrutineer:

The completed form will be kept by the election official. A new form is to be presented if the scrutineer wishes to appear at a different location.

- A candidate for Mayor or Councillor in a Council area cannot act as a Scrutineer in that Council area.
- A candidate for Mayor or Councillor in a Council area may act as a Scrutineer in another Council area.
- Scrutineers may be appointed to be present at each place at which polling is carried out, ballot papers are scrutinised or votes are counted.
- For candidates included in a group, such an appointment may be made by any or all of them.
- Due to COVID-19, scrutineers appointed for the 2022 Local council elections must comply with the COVID-19 safety measures at venues. For more details refer to form <u>Scrutineer and party/candidate worker guidelines LG.233</u>
