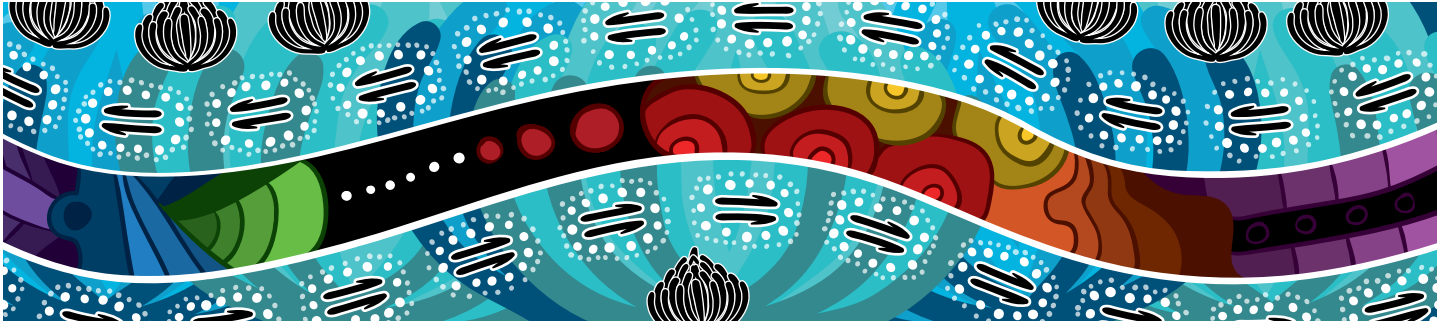


Postal vote application

2019 NSW Aboriginal Land Council election








The NSWALC 2019 Council Election will be held on 30 November 2019. This form is used to apply for a postal vote to be sent to your address. If you vote by post you will not have to visit a polling place in your region on election day. To be eligible to vote by post this form must be received by the NSW Electoral Commission by 6:00pm on the 25 November 2019.

Postal vote packs will be sent from Monday 11 November 2019

- Voting members will receive postal vote packs containing: ballot paper, instructions for postal voters, and a postal vote declaration envelope.
- If you apply for a postal vote but then decide to vote in person you will not be able to vote unless you hand the postal vote pack in at the polling place for cancellation.
- It is an offence to vote or attempt to vote in an election in which you are not entitled to vote, vote or attempt to vote more than once in an election, or make a false or wilfully misleading statement in this application.

Applications must be received by 6pm on Monday 25 November 2019
