Introduction

The Electoral Districts Commissioners, the Honourable Jerrold Sydney Cripps QC, an Acting Judge of the Supreme Court, Mr John Charles Wasson, Electoral Commissioner and Mr Warwick Arthur Watkins, Surveyor General, were appointed by Her Excellency the Governor, Professor Marie Bashir AC to hold Office from 17 October 2003 to 16 April 2004, subject to and in accordance with the provisions of the *Parliamentary Electorates and Elections Act 1912*. Due to ill health, the late Mr Wasson resigned his Commission in March 2004.

The redistribution of Electoral Districts was able to proceed under the provisions of the *Parliamentary Electorates and Elections Act 1912*. Part 2 Section 10 of the *Act* directs that at all meetings of the Commission two Commissioners shall form a quorum. The Chairperson shall have a casting vote in addition to his original vote, in the event of an equality of votes.

The term of the Office of the Electoral Districts Commissioners was extended by Her Excellency the Governor with the advice of the Executive Council of New South Wales, for the period from 17 April 2004 to 31 October 2004. Two Electoral Districts Commissioners, the Honourable Jerrold Cripps QC and Mr Warwick Watkins were appointed to hold Office until arrangements could be made to appoint a new Electoral Commissioner to the Electoral Districts Commission.

Requirements of Relevant Legislation

Provisions of section 27(1)(c) of the *Constitution Act 1902*, as amended, require a redistribution of electoral boundaries after two elections have been conducted using the same electoral boundaries. The last redistribution occurred prior to the 1999 State Election, after which the Legislative Assembly was reduced from ninety nine to ninety three Members. By virtue of the provision of 27(1)(c), the Electoral Districts Commissioners were appointed by the Governor on 16 October 2003 and directed to distribute New South Wales into electoral districts in accordance with the *Parliamentary Electorates and Elections Act 1912*.

If redistribution had not been required by the above section 27, one would have been required under section 28A of the *Constitution Act 1902*. A redistribution shall be made after one quarter of the number of electoral districts has been malapportioned for a period of more than 2 months. More than a quarter of New South Wales seats were malapportioned (ie an electorate being more than 5% above or below the average number of electors) for a period of more than two months when the Commissioners were appointed.

Section 14 of the *Parliamentary Electorates and Elections Act 1912*, as amended provides the notification requirements to proposed alteration of existing boundaries.

This requires amongst other things:

- the prescribed notice of any proposed alteration of an electoral district must refer to the fact that a written statement of the Commissioners' reasons for making the proposed alteration will be available for inspection at no cost during office hours at the office of the Electoral Commissioner for a specified period;
- for an extended process for objections to be submitted to the Commissioners and for objections to be dealt with before the completion of the distribution;
- for the Commissioners to regulate the conduct of proceedings at an inquiry into any suggestion or objection lodged with the Commissioners relating to a proposed alteration of an electoral district.

Section 28 of the *Constitution Act 1902* provides that, upon a distribution of New South Wales into electoral districts, the boundaries of each proposed electorate shall be so determined that, at the time the distribution is made, the number of persons entitled to vote at a general election of Members of the Legislative Assembly in each proposed electoral district is equal to a quota from which the number of persons in each electoral district will not vary by more than ten percent (10%). Under this section, the quota is obtained by dividing the number of persons entitled at that time to vote at any general election in all the proposed electoral districts by the number of the proposed electoral districts at the time of the distribution (ninety three in this distribution). The Commissioners have complied with the provisions of section 28.

Section 17A(1)(a) of the *Parliamentary Electorates and Elections Act 1912*, requires the Commissioners to have regard to demographic trends within the State and, as far as practicable, endeavour to ensure on the basis of those trends that, at the relevant future time the number of electors enrolled in each electoral district will be equal (within a margin of allowance of three percent (3%) more or less of the average enrolment in electoral districts at that future time).

Section 17A(1)(b) of the *Parliamentary Electorates and Elections Act 1912*, requires the Commissioners to give due consideration in relation to each district to:

- 1. community of interest within the electoral district, including economic, social, and regional interests;
- 2. means of communication and travel within the electoral district;
- 3. the physical features and area of the electoral district;
- 4. mountain and other natural boundaries; and
- 5. the boundaries of the existing electoral districts.

The Commissions have complied with the provisions of Section 17A (1)(a) and given due consideration to the provisions of 17A(1)(b).

Process and Timeframe

- Comments scanned, acknowledged and available for inspection at Office of Electoral Districts Commission.
- 12 January 2004 to July 2004
- Commissioners consider suggestions and comments received, to determine names and boundaries of electoral districts.

- Commissioners delineate proposed electoral districts and prepare index maps and written descriptions. Government printer completes 750 copies of Commissioners report; Department of Lands publishes 750 sets of index maps.

- Advertisements placed in metropolitan, major regional papers and the ethnic press advising process of lodging comments or objections concerning proposed electoral districts.

Enrolment Data and Quotas

The Commission was advised by the Australian Electoral Commission that number of persons who were enrolled in NSW at the base date was 4,276,695 (ie 'current enrolment').

Legislation also requires that 'relevant future trends' (see above) be considered by calculating the predicted number of electors at the relevant future time. The relevant future time is 29 April, 2007, being four years after the return of the writs for the most recent election. The Commission was advised by the Australian Bureau of Statistics that predicted number of electors would be 4,496,018.

The quotas are calculated by dividing the total current and predicted enrolments by the number of proposed electoral districts. The redistribution is then conducted using both of these quotas, which have a tolerance of 10% and 3% respectively.

Reasons for Making Proposed Alterations

The Commissioners received a total of forty three (43) suggestions and fifty eight (58) comments on these suggestions from political parties, local government, social and regional interests. These suggestions and comments focussed particularly on community of interests, especially economic, social and regional interests. These suggestions and comments were extremely helpful to the Commissioners in their deliberations and were given due consideration for each proposed electoral district.

The Commissioners in delineating the boundaries kept to current boundary configurations as a priority as far as was appropriate. The boundaries were defined, where possible, to include whole Local Government areas so as to maintain community of interest. Close attention was also paid to following major cultural features such as roads, motorways and railways and including whole waterbodies within proposed electorates eg Port Jackson in Sydney, Lake Macquarie in Swansea and Lake Illawarra in Shellharbour.

While the Commissioners' analysis of the current and projected enrolment statistics clearly showed an overall increase since the 1998 redistribution of 7% in the State's electors, it also showed a continuous decline in the number of electors in inland New South Wales. For example the existing electorates of Albury, Barwon, Murray-Darling have declined by 6%, 9% and 12% respectively on the current figures and by 7%, 12% and 17% on the predicted figures. Even electorates with major rural centres such as Bathurst, Orange, Dubbo and Wagga Wagga are declining on average by 4%.

The direct consequence of this decline was the abolition of one electoral district (Lachlan) and significant changes to others. The effect of a declining population can be illustrated by noting that the proposed electoral district of Albury has increased to over twice its current size in order to bring it within the proposed quota.

The large size of some electorates is also of concern to the Commissioners. The largest district, Murray-Darling, has been reduced in size by 26% from 340,000 km² to 250,000 km² while Barwon has increased in size from 117,000 km² to 222,000 km².

Coogee remains the smallest electoral district but it too has increased in size by 17% to 12.6 km².

The rural decline is balanced by substantial growth in the outer Sydney metropolitan area, the Central and Far North coasts and the Illawarra. This again has contributed to significant changes in the proposed boundaries particularly for Tweed in the north, Gosford area in the Central Coast and the Hills and Camden areas in outer Sydney. Existing electorates such as Tweed, The Hills, Camden and Macquarie Fields are over quota by 9%, 23%, 20% and 20% on the current figures and 13%, 25%, 26% and 25% on the predicted figures.

In the proposed electorates, whilst much of the surplus in the Hills area has been absorbed by the adjacent proposed districts of Ku-ring-gai, Epping, and Toongabbie (these areas were under quota at the base date) the Camden area has presented an opportunity to create a new electorate to compensate for the abolition of the electoral district of Lachlan. The new electoral district of Camden has been created from the surplus number of electors available in the existing districts of Camden and Macquarie Fields, as mentioned, and the northern half of the existing district of the Southern Highlands.

On the Central Coast and Hunter Valley the proposed electoral districts have contracted towards the coastal population centres and the proposed electorate of Port Macquarie is now closer to its eponymous regional centre.

The Commissioners noted that the required quota margin of 3% on the predicted figures was often restrictive to their collective desire to maintain community of interest within each electoral district. The Commissioners agreed that a 5% to 10% margin would enable a better fit with Local Government areas and community of interest concerns when defining the districts' boundaries. The Commissioners agreed that they will recommend review of this margin of allowance in their final report.

A number of suggestions were received from political parties, organisations and the members of the public on renaming electorates to reflect names of distinguished individuals. The Commissioners agreed to follow the current approach of using geographic or feature names to align with community identity.

A number of representations were received with regard to the confusion in using some current electorate names eg The Hills or Georges River. The Commissioners renamed the proposed electorates Castle Hill and Oatley respectively. Eleven electorates in total were renamed to better reflect community aspirations (see page 9).

The Commissioners note that references to local government areas have been withdrawn from this report as some boundaries to these areas are currently under review and any reference made now may be superseded and thereby cause confusion. The one exception to this is in the section on the proposed electoral boundary descriptions. Where reference has been made to local government boundaries in the proposed electoral boundary descriptions the gazetted date of the local government boundary has been included.

Names and Boundaries of Proposed Electoral Districts

Proposed State Electoral District of Albury

Commencing at the intersection of the generally south-eastern boundary of Shire of Tumbarumba, gazetted 26th May 2004 and the boundary between the States of New South Wales and Victoria; and bounded thence by the latter boundary, generally north-westerly and generally westerly to the generally western boundary of Corowa Shire, gazetted 26th May 2004; by that boundary and the generally northern boundary of that shire, generally northerly and generally easterly, the generally western and the generally northern boundaries of Greater Hume Shire Council, gazetted 26th May 2004; generally northerly and generally easterly, the generally northern boundary of Tumbarumba Shire, aforesaid, generally easterly to the centre of Talbingo Reservoir; by the centre of that reservoir generally south-easterly to Yarrangobilly River at Lobs Hole; by that river, Wallace Creek, Stable Creek and Milk Shanty Creek and its prolongation upwards to the generally south-eastern boundary of Tumut Shire, gazetted 11th February 2004; by part of that boundary and the generally south-eastern boundary of, again, Tumbarumba Shire, generally south-westerly to the point of commencement.

Proposed State Electoral District of Auburn

Commencing at the intersection of Hector and Marks Streets; and bounded thence by the latter street, westerly and Chester Hill Road generally northerly to Regents Park Railway; by that railway easterly to Hector Street, aforesaid; by that street northerly to the Sydney Water Supply Pipe Line; by that pipe line south-easterly to Duck River; by that river and Parramatta River downwards to Silverwater Road; by that road northerly

to the low water mark of the left bank of Parramatta River; by that low water mark downwards to Charity Point; by a line south-westerly to the generally eastern boundary of Auburn Council at Wentworth Point; by part of that boundary generally southerly to Campsie-Rookwood Railway, by that railway generally south-easterly to the northern prolongation of Wentworth Street; by that prolongation and street, southerly, Drone Street, westerly to the eastern boundary of Lot 4, DP 835847; by part of that boundary southerly and the northern boundaries of Lots 13 and 12, DP 1004336, and their prolongation, westerly to Roberts Road; by that road northerly, Rawson Road, Brunker Road and Ferrier Street, generally westerly, Rose Street, northerly, Palmer Street, westerly and Hector Street, aforesaid, northerly to the point of commencement.

Proposed State Electoral District of Ballina

Commencing at the junction of the southern boundary of Tweed Shire Council, gazetted 21st November 1986 with the mean low water mark of the shore of the South Pacific Ocean; and bounded thence by that boundary generally westerly and generally southerly to the Koonyum Range; by that range, generally south-easterly to Koonyum Range Road; by that road, generally southerly, Nanday Road, generally south-westerly and generally south-easterly, again, Koonyum Range Road, generally south-easterly, Wilsons Creek Road, generally easterly, Coolamon Scenic Drive, generally southwesterly and Goonengerry Road, generally westerly to Wilsons River; by that river, downwards to the generally eastern boundary of the Lismore City Council, gazetted 18th January 1991; by part of that boundary generally southerly

and the generally southern boundary of Ballina Shire Council, gazetted 9th January 1981, generally easterly to the mean low water mark of the shore of the South Pacific Ocean aforesaid, and by that mean low water mark (except at the entrance of any river, creek or inlet of the sea where the boundary shall be a straight line connecting two points on the shore opposite the outermost headlands at the entrance of any such river, creek or inlet of the sea) generally northerly to the point of commencement (inclusive of all islands lying off the coast of the district above defined).

Proposed State Electoral District of Balmain

Commencing at the intersection of Parramatta Road and Bay Street; and bounded thence by that street, northerly, Bellevue Road, north-easterly, Wattle Street and its prolongation generally north-westerly to the low water mark of the generally south-eastern shore of Blackwattle Bay; by that low water mark of that shore and the generally southwestern shore of that bay, the low water mark of the shores of Rozelle Bay and White Bay, generally westerly and generally north-easterly and the low water mark of part of the generally southwestern shore of Sydney Harbour, generally north-westerly to Yurulbin Point; by a line northerly to Manns Point; by the low water mark of the left banks of Parramatta River and Lane Cove River to a point east of Onion Point; by a line westerly to that point; by the low water mark of the right bank of Lane Cove River, downwards and the low water mark of the left bank of Parramatta River, aforesaid, upwards to Pulpit Point; by a line south-westerly to Drummoyne Wharf; by the low water mark of the right bank of Parramatta River, downwards, the low water mark of the generally north-western shore of Iron Cove, generally south-westerly, Iron Cove Creek, upwards to Parramatta Road,

aforesaid and by that road, generally south-easterly and generally easterly to the point of commencement.

Proposed State Electoral District of Bankstown

Commencing at the intersection of Canterbury Road and Fairford Road; and bounded thence by the former road and Milperra Road, generally westerly to Georges River; by that river and Prospect Creek, upwards to Liverpool Road; by that road, generally south-easterly, Hector Street, northerly, Palmer Street, easterly, Rose Street, southerly, Ferrier Road, Brunker Road and Rawson Road. generally easterly and Roberts Road, southerly to the western prolongation of the northern boundary of Lot 12, DP 1004336; by that prolongation and boundary, easterly, the northern, eastern and southern boundaries of Lot 13, DP 1004336, easterly, southerly and westerly and the southern boundary of Lot 10, DP 884274 and its prolongation, westerly to, again Roberts Road; by that road, generally southerly, Wattle Street, generally westerly and Stacey Street and Fairford Road, generally southerly to the point of commencement.

Proposed State Electoral District Of Barwon
