- contributions, entry fees or other payments to participate in a fundraising venture or function; and
- reportable loans (\$1,000 or more).

A political donation made by a person or entity of less than \$1,000 is to be disclosed as a reportable political donation if that donation and other, separate political donations made by the person or entity to the same recipient within the same financial year (from 1 July – 30 June) would, if aggregated, total \$1,000 or more.
