- small political donations (under \$1,000);
- reportable political donations (\$1,000 or more);
- annual or other subscriptions paid to a party;
- contributions, entry fees or other payments to participate in a fundraising venture or function;
- reportable loans (\$1,000 or more); and
- contributions made by group members into the group's campaign account.

In addition to a group form lodged by the lead candidate, each member of a group needs to lodge an individually completed candidate disclosure form.

When to lodge

Return completed form by **25/02/2022** using the contact details at the bottom of this page.

Penalties apply for failing to comply.
